An action plan may be chalked out and submitted to SMCG-UP for deputing officials of SMCG-UP to monitor the program in your District. Program may be organized excluding the holidays falling on the occasion of Holi i.e. 17th and 18th March, 2022.

Recping above in view, all DGCs are requested to prepare and submit the action plan to SMCG-UP latest by 05.03.2022 so that necessary action for releasing funds be

initiated by SMCG-UP timely.

Further, all DGCs notified recently (list annexed) are required to open their Bank Account in the Union Bank of India and share the bank details with the SMCG-UP to enable transfer of funds for this program. The Account will be opened in the name of "Zila Ganga Samiti-Name of the District" and jointly operated by the Chairman/District Magistrate and DFO /Convener of the concerned District Ganga Committee.
